

# Wauchope IGA Liquor 10<sup>th</sup> Birthday – \$200 Shareholder & Co-op 100 members competition

#### **Giveaway Rules and Conditions of Entry**

#### 1. The Prize

- **1.1.** The total maximum notional value of the prize pool awarded in this promotion is AUD\$200.
- **1.2.** The Prize is \$200 Hastings Co-op voucher valued at \$200.

# 2. Duration of Promotion and Entry Period

**2.1.** Entries for the Hastings Co-op 2020 Wauchope IGA Liquor's 10<sup>th</sup> Birthday - \$200 Shareholder & Co-op 100 members promotion must be received during the Entry Period. The Entry Period starts at 7.00am on Friday, August 28 2020 (28/08/20), and ends at 8:00pm Friday, August 28 (28/08/20).

# 3. Eligibility to Enter

- **3.1.** Entries can only be made by Shareholders & Co-op 100 members swiping their members card at Wauchope IGA Liquor during the Entry Period as stated in section 2.1.
- **3.2.** There can only be one entry per transaction, excluding tobacco sales.
- **3.3.** There is no limit to the amount of entries that can be lodged by any individual customer, however, only one entry will be awarded for each valid transaction.
- **3.4.** Hastings Co-op Public Officer and Directors and their immediate family members are ineligible to enter. Any entries received by Hastings Co-op Public Officer and Directors and any immediate family members of directors will be excluded from the draw and / or excluded from winning\*.

\* Except family members of Public Officers and Directors who are currently employed with Hastings Cooperative.

#### 4. Entry into Promotion

**4.1.** Valid entries are made by swiping a Shareholder or Co-op 100 members card at a Wauchope IGA Liquor register or by making an order online and submitting your Shareholder or Co-op 100 member details.

#### 5. Drawing winning entries, notification of winners and claiming prizes

- 5.1. All valid entries will be placed in a random automated draw and will be drawn on Monday, August 31.
- **5.2.** The Prize will be drawn at Midday on Monday, August 31 at the Corporate Office of Hastings Cooperative Limited, Level 1 9-13 High Street, Wauchope NSW 2446 in accordance with section 5.1.
- **5.3.** The winner of the Prize will be drawn eligible with a valid entry.
- **5.4.** Should an entry be drawn that is considered to be ineligible under section 3.4 it will be referred to an independent panel of three people comprised of community members independent of the Hastings Co-op who will make the final determination as to eligibility for the prize.
- **5.5.** The winner of the prize does not need to be present at the draw to claim the prize.
- **5.6.** As far as practicable, the winner will be notified within 2 days of the draw. The winners will be notified by telephone using the Shareholder or Co-op 100 member contact details.
- 5.7. The winner will be published on Hastings Co-op Facebook page by 5pm Wednesday, September 2, 2020.
- **5.8.** The winner of the Prize needs to claim their prize by arrangement with Hastings Co-op. The winner will receive the Prize no later than 6 weeks after the draw.

### 6. Right to Re-draw if Prize is unclaimed

- **6.1.** The winner must claim their prize within 3 months of being notified.
- **6.2.** If a prize is not claimed within 3 months of being notified, Hastings Co-op will take all reasonable steps to deliver the unclaimed prize to the winner. At the conclusion of 3 months, if the prize cannot be delivered, Hastings Co-op may re-draw the prize, subject to approval and any directions made by the Office of Liquor, Gaming and Racing.

### 7. Prize Ineligibility

**7.1.** If an ineligible or invalid entry is drawn another entry will be drawn until an eligible and valid entry is drawn.

# 8. General Conditions

- 8.1. All eligible and valid entries will be included in the draw.
- **8.2.** The prize is non-transferrable, non-changeable and non-extendable and cannot be exchanged for cash.
- **8.3.** Staff of the Hastings Co-operative and their immediate families are eligible to enter this promotion.
- **8.4.** The draw and announcement of the prize winner will be scrutinised by a community member independent of the Hastings Co-op.
- **8.5.** Hastings Co-op will use its best endeavours to provide the prizes listed in section 1. If any portion of the prize pool is unavailable for any reason, Hastings Co-op reserves the right to substitute the prize for a prize or item of equivalent value.
